Description

Stevia is a sweetener and sugar substitute derived from the leaves of the plant species Stevia rebaudiana, native to Brazil and Paraguay.

In the United States, high-purity stevia glycoside extracts have been generally recognized as safe (GRAS) since 2008 and are allowed in food products.

Rebaudioside A (sometimes shortened to "Reb A") is a steviol glycoside that is 240 times sweeter than sugar.
